Refund Policy

Parents who withdraw their students after June 1, 2011 will not receive any refund of fees. Tuition is refunded according to the following schedule: Prior to the first day of orientation – 100% (no refund of fees); between the first day of orientation and November 30 – 50% refunded. After November 30, no refund. Parents who finance tuition are required to pay out any balance owed within thirty days of the withdrawal. Completion of this application is an agreement to accept this policy.
